

PENGERTIAN DAN KONSEP TANGGUNG JAWAB HUKUM

A. Pendahuluan

Salah satu unsur penting dalam penyelenggaraan penerbangan adalah terkait keselamatan penerbangan. Berdasarkan Undang Undang Nomor 1 Tahun 2009 tentang Penerbangan, Keselamatan penerbangan adalah suatu keadaan terpenuhinya persyaratan keselamatan dalam pemanfaatan wilayah udara, pesawat udara, bandar udara, navigasi penerbangan, serta fasilitas penunjang dan fasilitas umum lainnya.

Penyelenggaraan penerbangan bertujuan mewujudkan penerbangan yang tertib, teratur, selamat, aman, nyaman, dll. Pengembangan penerbangan ditata dalam satu kesatuan sistem dengan mengintegrasikan dan mendinamisasikan prasarana dan sarana penerbangan, metoda, prosedur, dan peraturan sehingga berdaya guna serta berhasil guna¹. Untuk menjamin terwujudnya penyelenggaraan penerbangan yang memenuhi standar keselamatan dan keamanan, maka dalam UU Penerbangan diatur tentang penetapan program keselamatan penerbangan nasional, program keamanan penerbangan nasional, dan program budaya tindakan keselamatan yang mengacu pada regulasi ICAO. Program keselamatan penerbangan nasional memuat peraturan keselamatan, sasaran keselamatan, sistem pelaporan keselamatan, analisis data dan

CHAPTER 1

DEFINITIONS AND CONCEPTS OF LEGAL RESPONSIBILITY

In this Chapter I, the meaning of aircraft accidents, international and national flights is explained, the legal responsibilities of each are accountability, responsibility, and liability; the concepts of liability based on fault, the presumption of liability, and liability without fault are as follows:

A. Understanding

1. Aircraft Accident

Accident is an event that occurs while in flight from the departure airport to the destination airport where there is a loss (damage) caused by a collision or friction between the passenger and the aircraft, unless the loss (damage) is caused by the fault of the passenger himself or the passenger. being in a place where it should not be in that place or the occurrence of structural damage to the aircraft or the need to replace parts of the aircraft or the aircraft has been lost completely which cannot be found again.⁴⁸

A. Warawa System 1929

As time travel and air transport began to develop on a large scale, the 1929 Warsaw Convention was amended and supplemented to keep pace with developments in aviation technology. These changes and/or additions were contained in the 1955 The Hague Protocol with the aim that the 1929 Warsaw Convention was in accordance with the needs of society at that time. The Hague 1955 Protocol only entered into force on 1

KESIMPULAN

Pada saat berlakunya Stb.1939-100 dan UURI No.33 Tahun 1964 istilah yang digunakan adalah santunan bukan ganti kerugian. Perkataan "santunan" dimaknai ikut merasakan kesusahan yang dialami orang lain akibat kecelakaan pesawat udara. Jumlah santunan berdasarkan kearifan lokal, bukan ganti rugi karena jiwa tidak dapat dinilai dengan uang. Setiap kecelakaan pesawat udara penumpang diberi santunan yang besarnya tetap atau bertambah lebih besar dari pada santunan sebelumnya atas pertimbangan kearifan lokal.

Santunan penumpang Garuda di Manado 1966 sebesar Rp.300.000,00; Garuda di Branti tahun 1974 sebesar Rp.1000.000,00; Garuda di Palembang tahun 1975 sebesar Rp.1000.000,00; MNA di Tinombala tahun 1977 sebesar Rp.2.750.000,00; Garuda di Palembang tahun 1979 sebesar Rp.3.4000.000,00; di Krawang tahun 1980 sebesar Rp.3.400.000,00 dan Garuda di Polonia Medan tahun 1987 Rp.13.000.000,00, semuanya berdasarkan pertimbangan kearifan lokal tanpa memperhatikan perincian.

Dalam perkembangannya setelah berlakunya UURI No.15 Tahun 1992 dan UURI No.33 Tahun 1963, istilah yang digunakan dengan perkataan "santunan" atau "ganti rugi" tanpa memasalahkan perbedaan kedua istilah, namun demikian mulai menilai jenis-jenisnya ganti rugi penumpang yang meninggal dunia, ganti rugi bagasi tercatat, ganti rugi kargo dan ganti rugi terhadap pihak ketiga yang besarnya berbeda.

CONCLUSION

At the time Stb.1939-100 and UURI No.33 of 1964 came into force, the term used was compensation, not compensation. The word "compensation" is interpreted to share in feeling the distress experienced by other people due to an airplane accident. The amount of compensation is based on local wisdom, not compensation because souls cannot be valued in money. Each passenger aircraft accident is given compensation that is fixed or increases in size compared to the previous compensation based on local wisdom.

Compensation for Garuda passengers in Manodo 1966 amounting to Rp. 300,000.00; Garuda at Branti in 1974 amounting to Rp. 1,000,000.00; Garuda in Palembang in 1975 amounting to Rp. 1,000,000.00; MNA in Tinombala in 1977 amounting to Rp.2,750,000.00; Garuda in Palembang in 1979 amounting to Rp.3,400,000.00; in Krawang in 1980 Rp. 3,400,000.00 and Garuda in Polonia Medan in 1987 Rp. 13,000,000.00, all based on local wisdom without regard to details.

In its development after the entry into force of UURI No. 15 of 1992 and UURI No. 33 of 1963, the term used with the words "compensation" or "compensation" without questioning the difference between the two terms, nevertheless began to assess the types of compensation for passengers who died , compensation for
