As it is known that every country has various law enforcement officials with different positions according to government policies. However, this difference can be pushed aside by ASEANAPOL Members. Networking is a powerful weapon in resolving transnational crimes. On several occasions, the National Police have gone through this condition, one of which is the repatriation of corruption suspects, perpetrators of online gambling crimes from ASEAN Member Countries which can be done easily. The National Police were also given facilities to investigate TIP crimes in Cambodia, the Philippines and Thailand. Although these activities are often carried out bilaterally, it is undeniable that the closeness of police officials between countries who often meet, discuss and exchange experiences at ASEANAPOL meeting forums helps to facilitate this coordination and communication).*

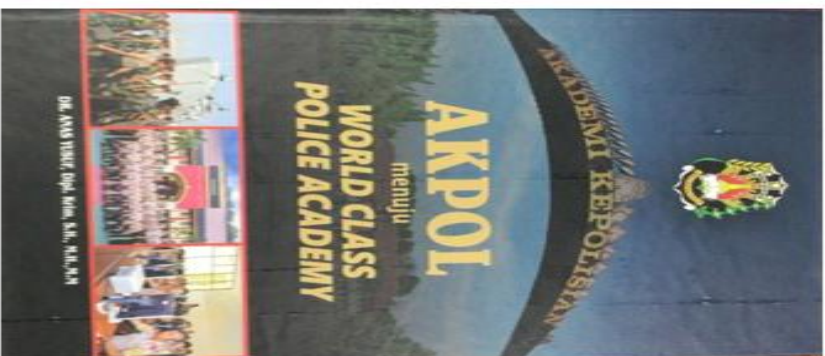
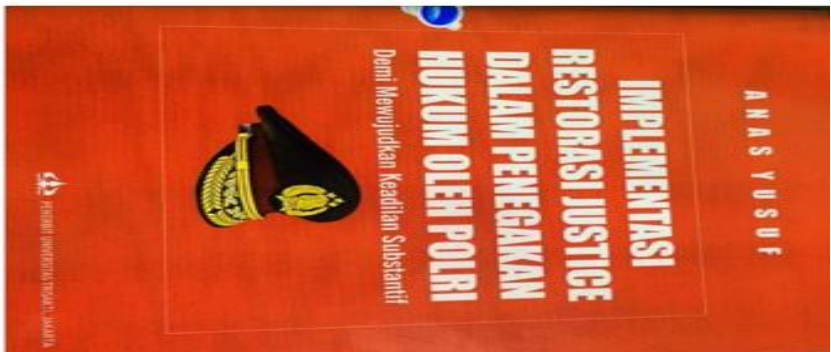
