Thus, good corporate governance is needed in the field of asset security to minimize the theft of fresh palm oil fruit bunches in plantations. CHAPTER 1 | INTRODUCTION

A. Background

The development of the plantation sub-sector as part of the development of the agricultural sector and national development is an important potential in efforts to improve people's welfare. The strategic role of the plantation sub-sector in improving the national economy is illustrated by its contribution in various ways, one of which is as a contributor to Gross Domestic Product (GDP).

In 2018, the plantation sub-sector was the highest contributor to GDP. Apart from being a contributor to GDP, the plantation sub-sector also contributes to building the national economy with high investment value; contributes to balancing the national agricultural commodity trade balance; source of foreign exchange from export commodities; contributes to increasing state revenues from excise, export taxes and export duties; provision of food and industrial raw materials; absorbing labour; as well as providers of renewable biofuels and bioenergy¹.

One of the plantation commodities that has an important role in the Indonesian economy is palm oil. Palm oil is an important plantation crop that produces food oil, industrial oil and biofuel (biodiesel). Palm oil has a positive influence on economic and social growth. As one of Indonesia's largest agricultural export commodities, palm oil has an important role as a source of large foreign exchange and tax revenues. In the

to safeguard assets. Before discussing the subject of this study, it is necessary to know the meaning, benefits and principles of GCG, as well as the legal basis for its implementation.

A. Definition, Benefits and Principles of Good Corporate Governance

In developed countries with relatively prosperous economies, good corporate governance (hereinafter referred to as GCG) has long been an issue. This problem is increasingly attracting the attention of the world community after a major crisis occurred. Such as the major crisis in the United States in 1929 and the banking crisis in England in 1970. In Indonesia, this problem has emerged since the major crisis which began in the third quarter of 1997⁶⁵. In general, practitioners and academics agree that one of the causes of this major crisis is still low

A. Good Corporate Governance

Good Corporate Governance, in state-owned companies (BUMN), hereinafter referred to as GCG, are the principles that underlie a company management process and mechanism based on statutory regulations and business ethics¹³⁵. The processes and mechanisms or governance in question are how a company is led, directed and controlled (lead, direct and control) and need to be described in the form of guidelines called Corporate Governance Guidelines (Code of Corporate Governance or Code of CG).

These Corporate Governance Guidelines are general guidelines for company management and are further elaborated into more detailed guidelines by each company organ by their duties and responsibilities. These guidelines are a refinement (revision) of the guidelines that were prepared in 2013. Material for the refinement of the Corporate Governance Guidelines comes from: the Company's Articles of Association; Law no. 40 of 2007 concerning Limited Liability Companies; Law no. 19 of 2003 concerning State-Owned Enterprises (BUMN), Minister of State-Owned Enterprises Regulation No. PER-01/MBU/2011 dated 01 August 2011 concerning the Implementation of Good Corporate Governance in State-Owned Enterprises (BUMN), which was last amended by Minister of State-Owned Enterprises

A. Research Result

1. History of the Development of Palm Oil in Indonesia

Before discussing the Obstacles and Efforts in Implementing Good Corporate Governance to Secure Assets in Palm Oil Plantation Companies in State-Owned Companies (BUMN) and private Companies in Indonesia, let the author first discuss the History of the Development of Palm Oil in Indonesia. West Africa is a country where palm oil originates. The Latin name is *Elaeis guineensis*, which from the beginning of its discovery was known to contain rich vegetable oil content that exceeds that of other plants. This plant was first introduced by the Dutch East Indies government in 1848. Initially, only four oil palm seeds were brought and then planted in the Bogor Botanical Gardens. The seed plants brought came from Mauritius (Bourbon) and Hortus Botanicus, Amsterdam, Netherlands. There was no thought that this plant would become a business plant at that time because the government at that time only considered it an

1. The principles of Good Corporate Governance in Palm Oil Plantation Companies in Indonesia, especially in State Companies (BUMN), have been regulated in Law No. 19 of 2003 concerning BUMN and its implementing regulations in the form of BUMN Ministerial Regulation No. PER-01/MBU/2011 concerning the Implementation of Good Corporate Governance (GCG) in BUMN, as well as BUMN subsidiaries, are required to implement GCG principles, namely: the principle of transparency; the principle of accountability (accountability); the principle of responsibility; the principle of independence (independence); and the principle of fairness. To safeguard assets in palm oil plantation companies in state-owned companies (BUMN), and private companies in Indonesia.
2. Implementation of Good Corporate Governance To Secure Assets In State-Owned Palm Oil Plantation Companies And Privately-Owned Companies In Indonesia to minimize theft of oil palm Fresh Fruit Bunches (FFB) in Palm Oil Plantation Companies in Indonesia, especially in State Companies (BUMN) and non-BUMN can be anticipated by using high-tech tools supported by the "Smart Security of Integrity" or "integrated technology security" application, which can minimize the security of assets in palm oil plantation companies in state-owned companies (BUMN), private companies in Indonesia.
3. The obstacles and efforts at Palm Oil Plantation Companies in Indonesia, especially at State Companies (BUMN) in the field of
